12. Glossary

Administrador Único (Sole Administrator)

Criminal responsibilities, if the sole administrator knows the existence of illegal acts by the company, and he/she doesn't report the authorities

In general, the position of sole administrator has no salary (wage) unless specified otherwise in statutes of the company.

Due to the large number of small and medium-sized companies (SMEs) in Spain, this is the most common appointment in this country. The sole administrators are under regulation by the law of capital companies, (1/2010).




